(c)(2)-(3), 15378; and authorize the City Manager to execute both contracts, subject to

any minor, technical, or non-substantive changes as approved by the City Manager and the City Attorney. **AYES:** Gregory, Strong, Bausch, Hamon **ABSENT**: Roden
