RESOLUTION 23-XXX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES APPROVING AWARD OF CONTRACT TO MGE UNDERGROUND, INC. FOR BOLEN DRIVE SINKHOLE AND STORM DRAINPIPE REPAIRS

WHEREAS, the City of Paso Robles was impacted by the January 9, 2023 storm event causing damage to both public and private infrastructure. The city enacted a State of Emergency due to the potential for storm intensity, risk to public health and safety on January 12, 2023; and

WHEREAS, City staff responded to a complaint of a sinkhole that was discovered in the backyard of 715 Bolen Drive on January 10, 2023; and

WHEREAS, the sinkhole appeared to be the result of a damaged storm drain pipe that runs east to west along the backyards of nine separate private properties along Bolen Drive; and

WHEREAS, the 36-inch corrugated metal storm drain pipe was installed as part of Tract 68 in 1957. In addition, the City maintains rights to a 28-foot-wide drainage easement; and

WHEREAS, City staff conducted a video investigation of the 36-inch corrugated metal pipe on March 2, 2023, to better assess the extent of pipe damage. The video footage recorded the entire 620 linear feet of the drain pipe; and

WHEREAS, a modification of the formal bidding procedure was necessary for this Project given the public safety concerns, and such a modification is permissible pursuant to Section 6.04.150(f) of the Municipal Code when reasonably necessary for the preservation or protection of public peace, health, safety or welfare of persons or property; and

WHEREAS, subsequent to two project meetings, the City received two informal quotes on May 9, 2023, which were reviewed and evaluated to identify the most effective repair methodology and approach; and

WHEREAS, MGE Underground presented a proposal that best fits the needs of the project and received the highest score based on the City's evaluation criteria; and

WHEREAS, General Fund Reserves are proposed to fund the emergency repair project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. All of the above recitals are true and correct and incorporated herein by reference.

Section 2. The City Council hereby approves a construction contract with MGE Underground, Inc. for the Bolen Drive Sinkhole and Storm Drain Pipe Repair Project in substantially the form attached hereto as Exhibit A, and incorporated herein by reference, and authorizes the City Manager to execute the Agreement, subject to any minor, technical, or non-substantive changes as approved by the City Manager and the City Attorney.

Section 3. Appropriate General Fund Reserves to fund the project in an amount not to exceed \$297,893.
