MGE, with support of Sancon Technologies, will provide manpower, equipment, and material to complete storm drain rehabilitation on Bolen Dr.

Proposal includes:

MGE & Sancon to use confined space entry procedures and equipment.

(Access points (1) West of Bolen, Storm drain export creek access, (1) residents back yard, 36" CMP grate access) to clean debris in 510' of CMP storm drain, repair damaged areas in CMP, fill voids in CMP, and prep 510'for CIPP liner installation.
