# 1. <u>Supplemental Sales Tax Oversight Committee</u>

**PUBLIC COMMENT: None** 

The Supplemental Sales Tax Committee provides a forum for citizens to review and report to both the City Council and the community as a whole on matters relating to Supplemental Sales Tax revenues and expenditures resulting from both Measure N-12, approved by the voters in 2012, and Measure J-20, approved by the voters in 2020. The Committee provides oversight of the expenditures of the supplemental sales tax revenues to ensure that they are being spent on community priorities established by the City Council, based on information gained from business and resident surveys and other means. The Committee shall determine if the funds were spent appropriately, and report that to the Council and public. The Committee may also provide advice to staff and the Council. The recruitment was for seven total member positions, three at-large membership positions and four community organization affiliate membership positions. As of the January 31, 2024 recruitment deadline, there

were only two applicants. Staff has extended the recruitment period in order to continue to solicit applications throughout the community and will return to Council at the earliest opportunity to bring future applicants forward for consideration. For the purposes of this interview session, Council will be appointing up to two positions. Applicants:

# 2. **Housing Authority**

#### **PUBLIC COMMENT: None**

The Paso Robles Housing Authority was established in the 1940s and is a separate Agency from the City of Paso Robles. The Authority is primarily responsible for development and operation of affordable and quality housing projects within the City, including the Oak Park Housing Project and the Chet Dotter Senior Apartment Community. The Housing Authority Board of Commissioners is responsible for policy, fiscal management, and the appointment of the Housing Authority Chief Executive Officer. There are seven commissioners, who serve overlapping four-year terms. The City Council appoints members of the Board of Commissioners and will interview to fill three vacancies for Board Commissioners. Two of the vacancies are for tenant commissioners. Applicants:

The Planning Commission prepares and recommends City Council consideration of the General Plan and Zoning Ordinance, including formulation of policies for development and land uses. The Commission also performs duties related to the

review and approval/denial of development applications and subdivision maps. The City Council will interview for two vacancies.
