RESOLUTION 24-XXX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES AWARDING PARK DESIGN AND ENVIRONMENTAL SERVICES CONTRACTS FOR LARRY MOORE PARK REDEVELOPMENT

WHEREAS, Larry Moore Park was developed in the 1980s as part of the Riverbank development and included in the Paso Robles Landscape and Lighting Maintenance District; and

WHEREAS, the park was accepted into the City park system in 2016; and

WHEREAS, data maintained by the Community Services Department indicates that the need for youth baseball fields and soccer fields exceeds available inventory and currently the City lacks three baseball diamonds and two youth soccer fields based on population size; and

WHEREAS, the City circulated an invitation to submit proposals for design services for Larry Moore Park Redevelopment; and

WHEREAS, seven firms submitted proposals of which two were interviewed by a panel consisting of members of youth sports organization, Parks and Recreation Advisory Committee and City staff; and

WHEREAS, the panel is recommending David Volz Design be retained to provide the requested design services; and

WHEREAS, the City Council finds that this action is not a project under the California Environmental Quality Act pursuant to State CEQA Guidelines, §§ 15060, subd. (c)(2)-(3), 15378, since the recommended action is to award two contracts only associated with environmental and design services and will not result in a direct or reasonably foreseeable indirect physical change in the environment. Full environmental review pursuant to the California Environmental Quality Act is required and SWCA Environmental Consultants is recommended to be retained for this scope of work.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. All of the above recitals are true and correct and incorporated herein by reference.

<u>Section 2.</u> The City Council hereby awards a contract in the amount of \$707,498.00 for landscape architecture design services for Larry Moore Park Redevelopment to David Volz Design and authorizes the City Manager to execute the Agreement, subject to any minor, technical, or non-substantive changes as approved by the City Manager and City Attorney.

<u>Section 3.</u> The City Council hereby awards a contract in the amount of \$144,042.86 for environmental services for Larry Moore Park Redevelopment to SWCA Environmental Consultants and authorizes the City Manager to execute the Agreement, subject to any minor, technical, or non-substantive changes as approved by the City Manager and City Attorney.

<u>Section 4.</u> Funds for the Larry Moore Redevelopment Project are to be allocated from the proceeds from the sale of a portion of Pioneer Park and Parks and Recreation Facilities Development Fees.
