ORDINANCE NO. XXXX N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES TO REPEAL ORDINANCE 1135 N.S, AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING PORTIONS OF PASO ROBLES MUNICIPAL CODE CHAPTER 12.42, PARKING MANAGEMENT

WHEREAS, in February 2024, the City determined that amendments to Chapter 12.42, Parking Management, were necessary to implement the Downtown Paid Parking Program ("Program"); and

WHEREAS, on February 7, 2024, the City suspended the implementation of the Program until amendments could be adopted to clarify the process for setting rates, reestablishing the downtown parking zone and other clean up measures; and

WHEREAS, on March 5, 2024, the City Council of the City of El Paso de Robles adopted Ordinance No. 1135 N.S. amending Chapter 12.42, Parking Management, to address the issues that had been identified with the existing Program; and

WHEREAS, following the adoption of Ordinance 1135 a referendum petition was circulated to place portions of Ordinance 1135 on the November 2024 ballot; and

WHEREAS, that petition failed to satisfy the requirements of the Elections Code and was rejected by the City Clerk as deficient; and

WHEREAS, though not required by law as the referendum petition is invalid and not binding on the Council, the Council has decided on its own motion to repeal Ordinance 1135; and

WHEREAS, prior to the implementation of any paid parking program in the future additional ordinances will be required to clarify the ambiguities in the existing Chapter 12.42 and to establish the paid parking area; and

WHEREAS, the City Council now desires to repeal Ordinance No. 1135 N.S.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 1135 N.S. adopted on March 5, 2024, amending Chapter 12.42, Parking Management, to clarify the process for setting rates, reestablishing the downtown parking zone and adopting other clean up measures, is hereby repealed and of no further force or effect.
