RESOLUTION 23-XXX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES AWARD CONSTRUCTION CONTRACT FOR THE 17TH STREET CHESTNUT TO SPRING STREET WATER AND SEWER UPGRADES AND REPAIRS

WHEREAS, at the March 1, 2022 City Council meeting, City Council adopted the 2022 CDBG Budget to install missing curbs, gutters, sidewalks, alley approaches, and upgrade curb ramps to Americans with Disabilities Act (ADA) standards for 17th Street from Chestnut to Spring Street; and

WHEREAS, on April 15, 2022, City Council authorized the City Manager to engage the services of Stantec to design the improvements, as noted above; and

WHEREAS, the budget adopted for FY 2022-23 expanded the CDBG project to include surface and road repairs; and

WHEREAS, the Water Master Plan identified the need to upgrade old and undersized water mains to improve fire flow within 17th Street from Chestnut to Spring Street; and

WHEREAS, the Sewer Operations Manual also identified several old sewer mains and manholes that have deteriorated and need repairs; and

WHEREAS, plans were prepared and advertised for bids for the underground pipelines and at the bid opening on March 2, 2023, six bids were received and ranged from \$726,880 to \$1,253,100, and Raminha Construction had the lowest quoted bid at that time; and

WHEREAS, Stantec will be assisting staff in providing construction phase engineering, including: construction staking, compaction testing for pipe trenching, review submittals and materials to ensure compliance with specifications; and

WHEREAS, Total project cost is \$801,738: for Stantec in the amount of \$74,858, and separately Raminha Construction in the amount of \$726,880.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. All of the above recitals are true and correct and incorporated herein by reference.

Section 2. The City finds that this action is categorically exempt under the California Environmental Quality Act under the Class 2 exemption, which applies to the replacement or reconstruction of existing structures and facilities, here sewer mains and manholes, where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced. (State CEQA Guidelines, § 15302.)

Section 3. The City Council hereby approves the 17th Street Chestnut to Spring Street Water and Sewer Upgrades and Repairs contract to Raminha Construction for water and sewer upgrades and repairs in the amount of \$726,880, and authorizes the City Manager to execute the Agreement, subject to any minor, technical, or non-substantive changes as approved by the City Manager and the City Attorney and approves continuing services by Stantec with respect to the same project, in the amount of \$74,858.
