Installation provider will not be held liable for damage to vehicles resulting from the Full Metal Jacket™ application process. In addition, and without limiting the foregoing, purchaser expressly acknowledges the existence of the pre-existing damage to vehicle described herein and releases Full Metal Jacket™, SPI, and installation provider from any liability or loss in connection with such damage including and exacerbation of the described damage.
