C. Employee and 30 Parking Study

Referring to Aug 20 City Council meeting, Item Q1 Discussion Item (Q)(1) Potential Modifications to the Downtown Employee Monthly Permit Parking and Short-Term Spaces

At that meeting I submitted my informal polling and made recommendations intended to take the least effort with the most positive impact. There was discussion and the council liked the idea of getting more feedback from business owners and employees.

The issue was referred back to City Staff to get more feedback from business owners and employees. Also for Chief Nord to report back on light enforcement of these.

The Acting City Mgr, Chris Huot, said it might take a few months to do that. I'd like to help expedite that by offering to do the work myself for free.

I will research the business owners and employees opinions, using the MainStreet Assoc member list via email and following up in-person to get responses from owners and employees. I'll consolidate the results and report back to City Staff, with my recommendations of course ;-).

I have a tentative list of the questions for Owners and one for Employees, keeping it short and simple and allowing for free form feedback.

I ask that you give me permission to proceed. Or I can proceed on my own recognizance.

D. Employee Lot Permits

As I understand it, Chief Nord turned off the employee permitting site, but there was no formal direction from the City Council or City Staff. Chief Nord can answer that.

That is limiting the use of the lots to employees with annual permits that are still valid. This leaves most employees to find parking elsewhere and is building possibly bad habits.

I believe this web site should already be active, according to the current municipal code.

I would like the City Council or City Manager to direct that to be turned back on immediately so that we can get as many employees out of the public retail spaces as possible. It would be at the \$5/mo written in the municipal code.

I ask that the City Manager direct that the Employee permit site be turned back on, or the City Council make a motion to direct City Staff to do that now.
